Revision 1.0 14 Dec 2019 Historian's report for December, 2019:

USS CAPELIN (SS-289) was actually on the second patrol when she was lost. CAPELIN returned to port early from her first patrol on 16 November 1943, for repairs and to disembark Commander Submarine Division ONE SIXTY-TWO, who had been embarked since CAPELIN got underway for the first patrol on 30 October 1943. CAPELIN commenced the second patrol, after repairs on 17 November 1943. The declassified first patrol report of CAPELIN is available via link https://issuu.com/hnsa/docs/ss-289_capelin. Also included at this link is the declassified "Record of Proceedings of an Investigation convened by the Commander Submarines, Seventh Fleet, to inquire into the possible loss of the U.S.S. CAPELIN (SS289) on her second war patrol."

This history presentation is the question and answers contained in the investigation report of Captain P.O. Nichols, U.S. Navy, Chief of Staff, Commander Submarines 7th Fleet, formerly Commander Submarine Division 162. This investigation occurred in March 1944.

The first question - basically - who are you and what do you do?

Question 2 - Can you tell me what you might consider pertinent information concerning the material condition of the hull, state of training and the morale of the officers and crew of the U.S.S. Capelin during her first war patrol?

Answer – On or about 27 October 1943, I was directed to proceed to the port in which the U.S.S. Capelin might be, and embark in the Capelin for a special mission and a war patrol. I was on the Capelin for about 19 days. During this period she patrolled in the Flores, Banda, and Berang Seas. I considered the Capelin to be in excellent material condition, the only casualties during the period I was in the ship were defective tubes in the SJ Radar, a defective conning tower hatch mechanism, and excessively noisy bow planes. The casualty to the hatch mechanism occurred early in the patrol and was repaired by the ship's force. It recurred frequently during the patrol and was embarrassing. The other casualties occurred later in the patrol and prior to my disembarkation. The casualties were reported to Commander Task Force 71, who ordered a repair group to the port of arrival. This group made complete and satisfactory repairs prior to departure on her second war patrol. I observed the Capelin from a material and personnel aspect very closely during the time I was on her. I considered her to be well above average as regards material and training. While I was in the Capelin, she made two attacks on single ships, both of which were successful, and both were sunk. The Commanding Officer was very aggressive, and I considered him to be a most competent submarine captain. In one attack, the enemy was escorted, and the Capelin was subjected to depth charging for about three hours. The attack was made on a bright moonlight night from periscope and radar depth. One hit was obtained on the first salvo, and the enemy attempted to make the beach, which was about two miles distant. In spite of the escort, who was dropping depth charges, the Commanding Officer remained at periscope depth, continued attacking until the ship was sunk, and not until then did he take the Capelin deep, and commence evasive tactics. The evasive tactics were very skillful and in about three hours he evaded the escort, surfaced and cleared the area. It was during this action that the excessively noisy bow planes became evident. Although one depth charge was fairly close, no damage was sustained.

Question 3 – You indicate that the Capelin had suffered casualties to bow plane and conning tower hatch which made continued submerged operations hazardous. On completion of repairs and prior to departure on her second war patrol, were these repaired in a fully satisfactory manner?

Answer – Yes. The trouble of the bow planes was only a matter of poor lubrication. A new greasing line was installed. The conning tower hatch casualty was caused by a badly burred worm shaft gear, which was replaced. The defective tubes in the SJ Radar were replaced. All repairs were inspected and tested in the presence of the Command Officer and myself, and we were satisfied that the Capelin was in all respects ready for the next patrol.

Question 4 – With regard to the operation order of the Capelin, did there appear any doubt in the mind of the Commanding Officer?

Answer – I received the Capelin's operation order from Commander Task Force 71 and delivered it to the Commanding Officer, Capelin. I went into and through it with the Commanding Officer, Capelin, and there was no doubt in his mind as to it.

Question 5 - Was there anything in connection with your association with the Capelin which would explain her failure to return from this patrol?

Answer – No.

Question 6 – Will you state the departure and arrival dates of the U.S.S. Capelin from and to Darwin on her first war patrol?

Answer – The Capelin departed Darwin on 30 October 1943, and returned to Darwin on 16 November 1943.

Question 7 – When did she leave Darwin on her second war patrol?

Answer – She departed Darwin about 1930 on 17 November 1943.

Question 8 – Are there any other facts concerning this investigation which you care to set forth?

Answer – No, except to state that the Commanding Officer, Capelin, was an outstanding, aggressive, and courageous officer. His officers and men were very well trained, his ship was well handled, both surface and submerged.

Finding of Facts

1. That the U.S.S. Capelin departed from Darwin, Australia on her first war patrol on 30 October 1945.

- 2. That she returned to Darwin on 16 November 1943 because of a defective conning tower hatch mechanism, excessively noisy bow planes and defective radar tube, all of which developed during her first patrol.
- 3. That the derangements were corrected to the satisfaction of the Commanding Officer of the U.S.S. Capelin, and that the ship then departed on her second patrol at about 1930 on 17 November 1943.
- 4. That nothing further has positively been seen nor heard of the U.S.S. Capelin since that date. The U.S.S. Bonefish upon return from her second war patrol, reported, that at 1753 (H), 2 December, in latitude 1° 10′ N, longitude 123° 50′ E, she sighted a submarine to seaward at a range of about four miles. This was in the area to which the Capelin was assigned. There are indications of the activity of the Capelin which for security reasons, cannot be divulged.
- 5. That on attempt to communicate with the Capelin by radio from Headquarters, Commander Task Force Seventy-One on 9 December 1943, elicited no response nor acknowledgement.
- 6. That the operation order and annexes thereto, under which she was conducting her patrol were clear and complete.
- 7. That her assigned route, to and from her operating area, was enemy controlled, but was not considered particularly hazardous, nor was her operating area itself considered unduly dangerous.
- 8. That all friendly forces were adequately informed concerning her routing, and that so far as in known, the U.S.S. Bonefish is the only friendly unit which made visual or other contact with a submarine in these areas during the period under question.
- 9. That the Commanding Officer was courageous and very aggressive, that his competence as a submarine captain was outstanding.
- 10. That the officers and men were very well trained, and the ship well handled, both surface and submerged. It was considered well above average from this standpoint.
- 11. That the material condition of the Capelin upon departure on her second war patrol was generally excellent, no defects were known to exist, and both the Commanding Officer and the Division Commander were satisfied that the Capelin was in all respects ready for the next patrol.
- 12. That there was nothing, other than the normal hazards of aggressive contacts with a formidable enemy, which could explain her failure to return.
