USS DRAGONET (SS-293) Construction, Commissioning & First War patrol

DRAGONET's keel was laid down on 28 April 1942 at [Cramp Shipbuilding Co., Philadelphia, and](#) launched 18 April 1943. DRAGONET was then moved to Philadelphia Navy Yard for completion and was commissioned there on 6 March 1944. Commander Jack Hayden Lewis in command.

DRAGONET was depth charged during a series of controlled tests in April, May, and June 1944 off [Portsmouth](#), New Hampshire. More information on this test is available via the link: [HyperWar War Damage Report 58 Submarine Report \[Section 18\]](#), Subsections; 18-6, 18-7, and 18-8.

DRAGONET reached [Pearl Harbor](#) from [New London](#) on 9 October 1944 and put out on her first war patrol on 1 November.

The body text of C.A. Lockwood, Jr, COMSUBPAC letter dated 3 January 1945 available via link https://issuu.com/hnsa/docs/ss-293_dragonet concerning DRAGONET's first patrol is as follows:

- "1. The first war patrol of the DRAGONET was conducted in the Kurile Islands and Sea of Okhotsk Areas.
2. Despite thorough area coverage, no contacts worthy of torpedo fire were made. On 15 December while conducting a submerged patrol south of MATSUWATO, the DRAGONET struck an uncharted rock and holed her forward torpedo room. While award of combat insignia is not authorized for this patrol, the courageous actions of the commanding officer, officers, and crew of the DRAGONET throughout the harrowing period of clearing the almost fatally damaged ship from the grounding and while enroute based in typhoon weather are deserving of the greatest praise."

The following are excerpts from the narrative section of DRAGONET's first war patrol report concerning the grounding.

On 15 December 1944 at 0515 "Submerged in RASHOWA Strait and commenced patrol to eastward. Depth control difficult in heavy tide rips."

At 0717 "In position Lat. 47-57.5N, Long. 143-08.5E, 6 miles south of MATSUWA TO, returning to 100 feet from 63 feet after a periscope observation. At 70 feet, course 090°(T), speed 2 knots, with 2° dive angle a slight jar was felt and ship broached to 58 feet. This was thought to have been an aircraft bomb. Negative tank was flooded and speed increased to gain depth. Rigged for depth charge attack. Hung at 90 feet with 20° dive angle, heavy grinding sounds forward and repeated jars, realized we were aground. Forward torpedo room reported flooding. Collision quarters and abandoned forward torpedo room. Blew all main ballast tanks and put pressure on compartment salvage air to forward torpedo room. Forward room reported completely flooded. Boat rose to 65 feet with very large dive angle and then began to sink again. Getting no place, and afraid that stern would clear and be sighted, from MATSUWA, ordered all

main ballast tanks flooded. Settled at 92 feet with 16° dive angle and pounding badly. Could not obtain suction with trim pump on forward trim tank. We were greatly concerned with the heavy pounding and grinding sounds that continued. It is essential that we got off before ship breaks up.

0732 Received report the water was receding in the forward torpedo room.

0735 Blow forward main ballast tank group and safety tank. Angle began to level off and ship rose slowly. Blew after main ballast tank group.

0738 Surfaced under the eyes of shore installations on MATSUWA, exchanged feel of temporary relief for one of shameful nakedness. Cut in all four main generators clearing area at best speed. With all the days of low visibility we have had, today would be one of unlimited visibility and ceiling. Shore installations clearly visible on MATSUWA as we ran for it.

0740 Steering "normal escape courses" at emergency ahead speed, about 17.3 knots. Large list to port and believe Nos. 2B and D M.B.T.'s have been holed.

0750 Blew all fuel ballast tanks and pumped variable tanks. Flooded No. 6A M.B.T. and No. 3A F.B.T. to compensate for list. The location of our grounding is well established. We were in a tide rip as shown on chart HO 5324 and encountering a westerly set. Navigational fixes had been obtained at 0607 and 0640 using points of references on MATSUWA TO and RASHOWA TO. Chart indicates 69 to 70 fathoms in this locality and from rocky to coarse sand and shell bottom."

At 2400 Changed time to zone -10.

16 December 1944 (-10)

At 0230 (K) Cleared message to radio and received receipt.

At 0832 (K) "Received COMSUBPAC 151921. Using fuel from No. 6 normal fuel oil tank to gain weight aft. Left No. 3A F.B.T. flooded to correct for list. Also flooded 8.5 tons into No. 3 auxiliary and left 13.5 tons in after trim tank. All other variable tanks pumped dry."

At 1800 (K) "In cyclonic storm. Barometer dropped 0.13 in one hour. Gale winds and heavy seas. Slowed to 5 knots and changed course frequently to find best sea condition to ride out storm. Bow planes are still rigged out and pounding continuously. Feels as though ship will come apart. Steadied on course 105° (T). Water rising in forward torpedo room. Leak around cable stuffing gland in bulkhead between forward battery and torpedo room causing water to enter pantry. Blew No. 1 normal fuel oil tank into No. 5A and B F.B.T. in effort to obtain an angle and reduce water level in torpedo room.

Developed 20° port list which settled down to a final 10 degrees. Rolling 40° to port. With the large free water surface in flooded compartment, it felt that we would roll over. Opened 5B flood valve and blew this tank to sea. This leveled the list. Pumped No. 3 Auxiliary dry. Taking fuel from starboard side of No. 6."

17 December 1944

At 0800 (K) "By morning seas had drawn around to the westward, bow was riding higher and the water level in the forward torpedo room down to about 6 inches above the floor plates. Still pounding heavily with bow planes rigged out. At the time of striking ground, the Mark 18 torpedoes in Nos. 1 and 4 tubes were half out being charged. These torpedoes are still in that position with inner doors open and outer doors closed but not locked. Put air pressure on forward battery compartment and equalized pressure between this compartment and the flooded torpedo room. Opened door to forward room and Commander A.F. SCHLECH, Jr., USN, Lieutenant J.K. HENRY, USN, and Lt(jg) R.G. STEWART, USN, with H.K. HALE CTM, USN and J.T. SCANLON, TM1c, USNR entered. Helmets to protect against chlorine gas were made available but were not needed. Air was foul with fuel oil fumes and oxygen was bled into the compartment. The torpedo tube outer doors were locked closed and the bow planes were rigged in by hand and secured by chains in the super structure. The forward room was again abandoned. As well as can be determined from observation the pressure hull has been ruptured between frames 21 and 22, port side, just above the top level of forward trim tank. The clock in the forward room had stopped at 0720, indication that it took about 3 minutes for the compartment to flood."

At 2350 (K) "Heavy seas and winds of gale force. Ship rolling badly."

18 December 1944 Set clocks ahead to zone -11 time.

At 0245 (L) "Ship rolled 63° to port and hung there righting herself very sluggishly and settling down with a 20° port list. Mercury spilled out of master gyro and compass went out of commission. Personnel were thrown out of bunks clear across compartments. Sea filled the port side of bridge, but fortunately did not reach the upper conning tower hatch. No. 6A M.B.T. flood hole was rolled clear of water allowing air pocket to collect there. This tank was vented and the port tanks blown to restore ship to even keel."

At 1245 (L) "Wind and sea abating."

Two days later DRAGONET's first patrol ended upon mooring at S10, Submarine Base, Midway at 0831 20 December 1944. DRAGONET entered ARD-6 at 1615 the same day for emergency repairs. On 23 December emergency repairs were completed and at 1511 DRAGONET was underway for Pearl. On 25 December DRAGONET "Celebrated Xmas with a fine meal and Santa Claus in the form of the American Red Cross delivered presents to all hands." At 1117 27 December 1944, DRAGONET moored at S/M Base Pearl.
